- A. Entering into a lease in 2025 will decrease staff time annually reviewing entry permit applications, as well as give the County ability to determine terms for eventual removal of the trailer
 - B. Annual revenue at a base rate of approximately \$9,000 with an annual 5% increase
 - C. Milwaukee County Parks budgets permits and fees for Right of Entry permits in the annual budget. The execution of this lease will only change the location the revenue is reflected but gives the department more control and certainty with the user.
 - D. A year over year increase of 5% is assumed in this form.
