Request to amend the Milwaukee County Code of General Ordinances Chapter 69 Section 69.02 to add a 'No Parking' zone South 13<sup>th</sup> Street (CTH V) from W. Lois Ln. to W. York Ave., by recommending adoption of the following:

**A RESOLUTION/ORDINANCE**

WHEREAS, Section 69.02 of the Milwaukee County Code of General Ordinances establishes parking regulations on Milwaukee County (the County) highways, pursuant to the authority established by Section 349.13, Wisconsin State Statutes; and

WHEREAS, a request was made by the City of Oak Creek to the Transportation Services Division, Department of Transportation (DOT), to review a concern of vehicles parking along South 13<sup>th</sup> Street (County Trunk Highway [CTH] V) from West Lois Lane to West York Avenue; and

WHEREAS, the Transportation Services Division-DOT has determined that there is a potential safety concern of vehicle sight distance, weaving, and lack of shoulder on South 13<sup>th</sup> Street – CTH V; and

WHEREAS, the Committee on Transportation and Transit (T&T), at its meeting of March 7, 2023, laid over File No. 23-352 for one meeting (vote 4-0); and

WHEREAS, T&T, at its meeting of April 11, 2023, recommended adoption of File No. 23-352 (vote 4-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 69.02 of the Milwaukee County Code of General Ordinances, by adopting the following:

**AN ORDINANCE**

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

**SECTION 1.** Section 69.02 of the Milwaukee County Code of General Ordinances is hereby amended as follows:

69.02. – Parking prohibited in designated areas.

No person shall stop or leave any vehicle standing in any of the following places, except temporarily, for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a licensed operator:

- 47 (1) College Avenue (C.T.H. 'ZZ')
- 48 (a) Between the limits of South 20th Street and South 27th Street.
- 49 (b) On the south side, from a point four hundred fifty (450) feet east of
- 50 South 35th Street to the limits of South 27th Street.
- 51 (2) South 76th Street (C.T.H. 'U')
- 52 (a) Between the limits of West Grange Avenue and West Layton Avenue.
- 53 (b) Between the limits of West Ryan Road and a point three-fourths ( $\frac{3}{4}$ ) of
- 54 a mile north of Ryan Road.
- 55 (c) Along the west side of South 76th Street (C.T.H. U) from a point six
- 56 hundred fifty (650) feet south of the south line of West Ryan Road to a
- 57 point nine hundred seventy-five (975) feet south of the south line of
- 58 West Ryan Road.
- 59 (d) Along the west side of South 76th Street (C.T.H. U) from a point one
- 60 thousand seventy-five (1,075) feet south of the south line of West Ryan
- 61 Road to a point one thousand two hundred (1,200) feet south of the
- 62 south line of West Ryan Road.
- 63 (3) Good Hope Road (C.T.H. 'PP')
- 64 (a) Between the limits of North Port Washington Road and North Pierron
- 65 Road.
- 66 (4) South 68th Street (C.T.H. 'A')
- 67 (a) Between the limits of West Ryan Road and a point three-fourths ( $\frac{3}{4}$ ) of
- 68 a mile north of Ryan Road.
- 69 (5) West Beloit Road (C.T.H. 'T')
- 70 (a) North side of the road from the intersection of South 108th Street
- 71 (S.T.H. 100) to a point five hundred seventy (570) feet east of South
- 72 108th Street.
- 73 (b) On both sides of the street from 100 feet east to 100 feet west of the
- 74 Root River Oak Leaf Trail Crosswalk east of West Howard Avenue.
- 75 6) West Layton Avenue (C.T.H. 'Y')
- 76 (a) From the limits of South 60th Street to a point eight hundred twenty-
- 77 five (825) feet east of South 60th Street.
- 78 (b) On the south side of the street from the limits of South 49th Street to
- 79 the limits of South 48th Street.
- 80 (7) South 92nd Street (C.T.H. 'N')
- 81 (a) On the west side of the street from the limits of West Howard Avenue
- 82 to the limits of West Waterford Avenue.
- 83 8) West Rawson Avenue (CTH 'BB')
- 84 (a) On both sides of the street from South 27<sup>th</sup> Street to South Howell
- 85 Avenue.
- 86 **(9) South 13th Street (C.T.H. 'V')**
- 87 **(a) On both sides of the street from West Lois Lane to West York**
