Subject: ShotSpotter Updates to Milwaukee County

Good morning Allyson,

Your inquiry related to the MPD providing an update on the ShotSpotter system was forwarded to our office. In 2013, Milwaukee County made a one-time \$175,000 appropriation to the City of Milwaukee for its ShotSpotter technology. The City then sought and received a \$175,000 appropriation from the State of Wisconsin to fund the difference required to meet the \$350,000 to expand the program. We appreciate Milwaukee County's contribution to fund 50% of the initial expansion of this important program.

Since 2013, the MPD has been providing quarterly updates to the Committee on Judiciary, Safety, and General Services relative to the SST system. However, the appropriation linked to these updates is not ongoing.

We are glad to hear there continues to be interest amongst County Supervisors in the SST program. Therefore, MPD is happy to share, by written communication, the progress report it provides to the State of Wisconsin Department of Justice as a condition of receiving the ongoing annual grant that matched the one-time County funds. As always, Board members may forward specific inquiries regarding SST to MPD throughout the year.

The Milwaukee Police Department appreciates Milwaukee County's past contribution towards the SST system and looks forward to the continued dialogue regarding this program. If you have any questions or concerns, please feel free to call or email me.

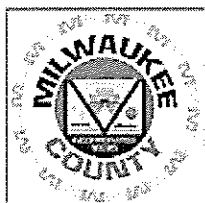
