From the Director, Child Support Services, requesting authorization to execute a Purchase of Service Contract with the Center for Veterans Issues in the amount of \$370,800 to provide Children First case management and program activities for the period effective January 1, 2019, through December 31, 2019, and requesting a waiver of Section 56.30(9) of the Milwaukee County Code of General Ordinances, to pay for services rendered prior to execution of the contract, by recommending adoption of the following:

**A REVISED RESOLUTION**

WHEREAS, Milwaukee County (the County) through the State of Wisconsin (the State) has Children First funding to assist participants in achieving self-sufficiency under Sections 767.55 and 49.38 of the State Statutes; and

WHEREAS, the Children First contractor (the Contractor) site facilitates case referrals and Children First activities, including, but not limited to employability plans; and

WHEREAS, the Children First Contract provides that the contractor assist the County in collection of child support obligations with services provided to support payers; and

WHEREAS, the Contractor will be entitled to payment of \$400 per participant enrolled in the Children First Program in a 12-month period; and

WHEREAS, the term of the contract shall be from January 1, 2019, through December 31, 2019; and

WHEREAS, the Department of Child Support Services released a Request for Proposals on September 25, 2018; and

WHEREAS, Center for Veteran’s Issues was notified of the award on October 26, 2018; and

WHEREAS, the Department of Child Support Services is requesting authority to pay bills for work done prior to the contract being executed; and

WHEREAS, the Committee on Finance and Audit, at its meeting of February 1, 2019, recommended adoption of File No. 19-67 (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Director, Child Support Services, to execute a Purchase of Service Children First Contract with the Center for Veterans Issues in the amount of \$370,800 for the term effective January 1, 2019, through December 31, 2019; and
