
DESCRIPTION OF FISCAL EFFECT

- A. Approval of this resolution will authorize and request the Director, Retirement Plan Services, Department of Human Resources, to prepare a report outlining the steps required to transition the County from operating its own separate defined pension plan on behalf of its employees and instead participating in the State of Wisconsin Retirement System (WRS).
 - B. This resolution is expected to require staff time to prepare, but it is not anticipated to require an expenditure of funds. It is understood that if policymakers continue to pursue transitioning to the WRS, an expenditure of funds will most likely be required to perform fiscal, actuarial, and legal analysis of such a move. Adoption of this resolution does not commit the County to transitioning to the WRS, or expending further funds for this purpose.
 - C. No budgetary impact is anticipated.
 - D. No assumptions were used.
