
A. The Milwaukee County Zoo is requesting the creation of temporary assignment position of Staff Veterinarian as permitted in Chapter 17.08 of the General Ordinances of Milwaukee County. The position is necessitated due to absence of both full-time staff veterinarians for medical leave.

B. Funding for the position will be absorbed through staff vacancies if possible or an appropriation transfer from the Zoo Specimen Fund will be requested.

C. The Milwaukee County Zoo is required to maintain appropriate staffing levels to remain in compliance with the United States Department of Agriculture Animal, Plant Health Inspection license. The presence of a staff veterinarian is critical to provide animal care for the animal collection and maintain licensure.

D. This analysis assumes an annual salary of \$72,381 for a Staff Veterinarian.
