	<p>Matt Fortman, Fiscal Administrator provided the 2026 Milwaukee County Behavioral Health Services Recommended Budget Narrative. He noted that this proposed budget includes service cuts for 2026 and advised that 2027 may continue to be difficult.</p> <p>This item was informational.</p>
4.	<p><b>Finance Committee Reserve Recommendation.</b></p> <p>It was noted that the memo included in the packet was not taken to vote in the finance committee meeting this morning and has been laid over to a future finance committee meeting.</p> <p>Board Member Tapper provided an update to the reserve that was discussed in the finance committee this morning. 5.	<p><b>Milwaukee County Behavioral Health Services 2026 Recommended Budget Consideration</b></p> <p>Board Member Tapper provided a summary of the approved amendments on the record. This included:</p> <ul style="list-style-type: none"><li>(1) Fund The Parachute House Peer-run Respite Service at \$100,000 for CY2026 for Room and Board Contingent on Ongoing Operation. 6.	<p><b>Milwaukee County Mental Health Board Discussion of Milwaukee County Board of Supervisors Reference File # 25-480.</b></p> <p>Chairperson Neubauer read the Resolution in Milwaukee County Board of Supervisors' File No. 25-480 on the record.</p> <p>Mike Lappen, BHS Administrator provided an update as to Wis. Stats. 971 Civil Commitment Cases. He noted he could not discuss a particular case's information but rather will keep comments general. He provided an update as to criminal proceedings that convert to civil commitments. He indicated that a 14-day notice was required in the statutes and specific to this case; the department does not dispute that the DA did not receive a 14-day notice. He highlighted that there is not a requirement to provide a notice specifically to the public. He provided an update of the procedures that are in place to provide the required oversight of 971 conversion cases. He also noted that there are 15 current chapter 51 cases that originated from 971 cases, and they are all in good standing.</p> <p>Questions and discussion ensued. Board Member Bottoni made comments regarding the proposed statute changes. Board Member Lehrmann spoke to the complexity of the legal system specific to mental health cases. He indicated that in his opinion that the care and support of the individual in this case was managed appropriately. She requested that board members provide an update as to their availability within the next couple weeks. Board Member Ginlack made comments regarding Governance Committee input in the process of the board retreat.</p> <p>Chairperson Neubauer provided an update as to Board Member Amoasi's radio show on WNOV Radio: Nyumba Upendo. She indicated that the show is on Wednesdays at 11-12 and the Mental Health Board has a designated spot on the 3<sup>rd</sup> Wednesday of every month starting August 20, 2025. Board Member Lehrmann thanked and commended Board Member Amoasi for the opportunity to use this platform.</p> <p>This item was informational.</p>
