A. It is requested that Milwaukee County modify the Concession Leasing Policy to allow the Airport Director the ability to establish a free-standing kiosk and mobile cart concession program at General Mitchell International Airport.


B. The airport is not able to estimate how much additional revenue could be generated through this change in the concession program. There is no anticipated expense associated with this change.

C. Although additional revenue is likely to be generated over time from this change, it cannot be estimated at present. There is no budgeting impact.

D. It is assumed that a pilot program consisting of free-standing kiosk and mobile carts will be established at predetermined locations at General Mitchell International Airport. Revenue estimates for future budgets will be determined after the program is implemented.
