Wellpath Amendment 8 for People in Our Care (PIOC) Health Care Services Extension, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Community Reintegration Center (CRC) oversees the Master Agreement (the Agreement) for health care services with Wellpath LLC (Wellpath) for the Criminal Justice Facility (CJF) and the CRC; and

WHEREAS, Milwaukee County (the County) and Wellpath (the Parties) entered into an Agreement for Persons In our Care (PIOC), effective as of February 27, 2019 (as previously amended from time to time), relating to the provision of health care services and delivery to PIOC populations at the CJF and CRC; and

WHEREAS, the term of the Agreement expires on March 31, 2026, and the Parties desire to exercise the first of three one-year extension options to extend the Agreement for one additional year; and

WHEREAS, both parties wish to allow PIOC to utilize the Wisconsin Human Immunodeficiency Virus (HIV) Drug Assistance Program, to promote the health of people living with HIV by subsidizing or paying for better access to medical care and antiretroviral and other HIV-related medications, and to reduce costs for patients and the County; and

WHEREAS, the County seeks to update certain contract terminology, contact information, and compliance with applicable County policies guiding agreements; and

WHEREAS, both Parties agree that all changes are cost neutral and will not affect current or future billing; and

WHEREAS, the Committee on Judiciary, Law Enforcement, and General Services, at its meeting of March 10, 2026, considered File No. 26-319 for informational purposes only, per Section 59.52(31)(d), Wisconsin State Statutes; and

WHEREAS, the Committee on Finance, at its meeting of March 12, 2026, recommended adoption of File No. 26-319 (vote 7-0); now, therefore,

41 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes
42 the Superintendent, Community Reintegration Center (CRC), or her designee, to amend
43 the Professional Services Contract with Wellpath LLC for Persons In Our Care health
44 care services and to exercise the first of three one-year extension options, extending
45 the Agreement for one year for the period effective April 1, 2026, through
46 March 31, 2027, unless terminated earlier, in accordance with the Agreement; and

48 BE IT FURTHER RESOLVED, the aforementioned contract will only be executed
49 after review and approval by the Office of Economic Inclusion, Department of
50 Administrative Services (DAS), the Office of Corporation Counsel, and the Office of Risk
51 Management, DAS.
