Policy

The 2018 Adopted budget requested changes to Chapter 15, 47.031 and 47.32 of the Milwaukee County Code of Ordinances. The Milwaukee County Clerk and Corporation Counsel requested that the changes be submitted as separate files effective 1/1/2018.

Background

Changes to Chapter 47.32 remove the fees and time restrictions for the Mitchell Park Conservatory from Ordinance. Each year the County Board reviews and approves a new fee schedule. Removing the fees from Ordinance reduces restrictions placed on times of free entry as well as time spent on administration.

Recommendation

Authorize Parks to enact changes to Chapter 47.32 removing the fees and time restrictions for the Mitchell Park Conservatory from Ordinance.
