From the Director and Chief Information Officer, Information Management Services Division, Department of Administrative Services (DAS-IMSD), requesting approval to execute a contract, consisting of a Master Services Agreement with exhibits and a Statement of Work (“contract”), with OneNeck IT Solutions LLC, for data center and disaster recovery services for a three-year period with one optional one-year extension for total fees of \$5,045,689.08, by recommending adoption of the following:

A RESOLUTION

WHEREAS, in 2016, the Milwaukee County Board of Supervisors and the County Executive approved a five-year contract with OneNeck IT Solutions, LLC (OneNeck), with one optional one-year renewal; and

WHEREAS, the Information Management Services Division (IMSD), Department of Administrative Services (DAS), in conjunction with the Procurement Division, DAS, Risk Management Division, DAS, and Office of Corporation Counsel, negotiated a new contract with OneNeck, for the continuation of data center and disaster recovery services, that moves Milwaukee County (the County) to new infrastructure technology, improves disaster recovery capabilities, and reduces projected annual costs; and

WHEREAS, the contract with OneNeck for data center and disaster recovery services is currently valued at \$5,045,689.08 for three years, with one optional one-year extension; and

WHEREAS, IMSD-DAS indicates on-going support costs are variable, and will likely fluctuate as the County’s need for Information Technology services expands and contracts (i.e., Monthly Service Adjustments); and

WHEREAS, IMSD-DAS and OneNeck have agreed to conduct an annual evaluation of the net impact of the Monthly Service Adjustments; and

WHEREAS, if modifications to the monthly service fees are required, IMSD-DAS and OneNeck will execute a Change Order, which shall also be approved by the County Executive, Office of Corporation Counsel, and Office of the Comptroller, and paid from the IMSD-DAS operating budget; and

WHEREAS, the Committee on Finance, at its meeting of December 8, 2022, recommended adoption of File No. 22-1143 (vote 7-0); now, therefore,

42 BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board)
43 hereby authorizes the Director, Department of Administrative Services (DAS), and Chief
44 Information Officer, Information Management Services Division, DAS, to enter into a
45 three-year contract with one optional, one-year extension, effective January 1, 2023,
46 with OneNeck IT Solutions, LLC (OneNeck), to provide data center and disaster
47 recovery services for Milwaukee County (the County), for total fees of \$5,045,689.08;

50 BE IT FURTHER RESOLVED, the County Board hereby authorizes the Director,
51 DAS, and Chief Information Officer, IMSD-DAS, Milwaukee County Comptroller, County
52 Executive, and the Office of Corporation Counsel (Corporation Counsel), to sign and
53 execute this Agreement with OneNeck; and

55 BE IT FURTHER RESOLVED, the County Board hereby authorizes the Director,
56 DAS, and Chief Information Officer, IMSD-DAS, the County Executive, Corporation
57 Counsel, and the Office of the Comptroller to execute a Change Order, if modifications
58 to monthly fees are required.
