- A. Milwaukee County Parks is requesting authorization to accept a grant from Milwaukee Metropolitan Sewerage District (MMSD) as the landowner of 1840 North 40th Street, Milwaukee, Wisconsin 53208. Milwaukee County Parks is accepting the grant on behalf of its lessee, the Urban Ecology Center (UEC), for the purpose of installing Green Infrastructure. This infrastructure includes native landscaping, porous pavement, and bioswales; the total capture capacity of this project is 18,212 gallons. After the completion of the project, a conservation easement in favor of MMSD will be executed for a term of 20 years.
 - B. Staff time will be utilized to ensure the Urban Ecology Center meets its obligations to maintain the GI infrastructure's functionality for twenty years in compliance with the grant requirements.
