Milwaukee County DOT applied for a grant of \$274,898 through the USDOT's SS4A Discretionary Grant program in July to fund five different municipalities' Demonstration Activities to implement and study temporary traffic calming and street safety initiatives. If awarded, the USDOT would provide \$219,918 (80%) and the municipalities would provide the combined local match of 20% (\$54,980). No Milwaukee County funding is required, if awarded.
