7 AN ORDINANCE
8

9 The Milwaukee County Board of Supervisors of the County of Milwaukee does ordain as
10 follows:

11
12 **SECTION 1.** Section 69.02 of the Milwaukee County Code of General Ordinances is
13 hereby amended as follows:

14
15 69.02. – Parking prohibited in designated areas.

16
17 No person shall stop or leave any vehicle standing in any of the following
18 places, except temporarily, for the purpose of and while actually engaged in
19 loading or unloading or in receiving or discharging passengers and while the
20 vehicle is attended by a licensed operator:

22 (1) College Avenue (C.T.H. 'ZZ')

23 (a) Between the limits of South 20th Street and South 27th Street.

24 (b) On the south side, from a point four hundred fifty (450) feet east of
25 South 35th Street to the limits of South 27th Street.

26 (2) South 76th Street (C.T.H. 'U')

27 (a) Between the limits of West Grange Avenue and West Layton Avenue.

28 (b) Between the limits of West Ryan Road and a point three-fourths (¾) of
29 a mile north of Ryan Road.

30 (c) Along the west side of South 76th Street (C.T.H. U) from a point six
31 hundred fifty (650) feet south of the south line of West Ryan Road to a
32 point nine hundred seventy-five (975) feet south of the south line of
33 West Ryan Road.

34 (d) Along the west side of South 76th Street (C.T.H. U) from a point one
35 thousand seventy-five (1,075) feet south of the south line of West Ryan
36 Road to a point one thousand two hundred (1,200) feet south of the
37 south line of West Ryan Road.

38 (3) Good Hope Road (C.T.H. 'PP')

39 (a) Between the limits of North Port Washington Road and North Pierron
40 Road.

41 (4) South 68th Street (C.T.H. 'A')

42 (a) Between the limits of West Ryan Road and a point three-fourths (¾) of
43 a mile north of Ryan Road.

44 (5) West Beloit Road (C.T.H. 'T')

45 (a) North side of the road from the intersection of South 108th Street
46 (S.T.H. 100) to a point five hundred seventy (570) feet east of South
47 108th Street.

48 (b) On both sides of the street from 100 feet east to 100 feet west of the
49 Root River Oak Leaf Trail Crosswalk east of West Howard Avenue.

50 (6) West Layton Avenue (C.T.H. 'Y')

51 (a) From the limits of South 60th Street to a point eight hundred twenty-
52 five (825) feet east of South 60th Street.

53 (b) On the south side of the street from the limits of South 49th Street to
54 the limits of South 48th Street.

55 (7) South 92nd Street (C.T.H. 'N')

56 (a) On the west side of the street from the limits of West Howard Avenue
57 to the limits of West Waterford Avenue.

58 (8) West Rawson Avenue (CTH 'BB')

59 (a) On both sides of the street from South 27th Street to South Howell
60 Avenue.

61 **(9) South 13th Street (C.T.H. 'V')**

62 **(b) On both sides of the street from 1300 feet South of West Elm**
63 **Road to 500 feet North of West Elm Road.**

65 **SECTION 2.** The provisions of this Ordinance shall be effective upon passage and
66 publication.
