If this proposal is adopted, Milwaukee County Parks will be authorized to enter into a Professional Service Agreement, pursuant to a Request for Proposal, for an aquatic master plan with Williams Associates Architects, LTD. The maximum fee for this agreement is \$130,000. This Professional Service Agreement is for capital budget project WP0724-Aquatics Master Plan.
 - B. This request has no fiscal impact. Milwaukee Metropolitan Sewerage District has agreed to provide funding for the study from the designated funding for the repair or replacement of the pool facility in Jackson Park outlined in the agreement approved in File #20-186.
 - C. Sufficient funds are budgeted as the funding is being provided by Milwaukee Metropolitan Sewerage District. Existing capital project #WP072401
 - D. No assumptions or interpretations were used.
