Brief Summary

On the date and time above, while in housing unit 6D on an inspection. Occupant [REDACTED] expressed suicidal statements through her cell door. She also was in the act of flooding her cell. I approached the occupant's cell and gave her orders to place her hands behind her back in order to be secured for a mental health evaluation and to be moved to another housing unit. The occupant eventually complied. It should be noted that the Occupant is on disciplinary status due to a fight with another occupant that occurred yesterday.

While escorting the Occupant down the housing units stairs, she began to walk briskly down, pull away, and became resistive. When told to slow down and to relax, she made threats to make her and I fall down the stairs. I then pulled the occupant closer to me in order to better control her movements to prevent injury. As I continued to assist the occupant down the staircase, Officer [REDACTED] attempted to assist. The Occupant then turned her aggression towards the officer and continued to resist. Due to her level of resistance, her aggressive behavior, and her know previous history the occupant was decentralized to the ground and stabilized. While on the ground, the occupant kicked Officer [REDACTED] on the right side of her body causing pain and discomfort. This was done without the consent of the Officer.

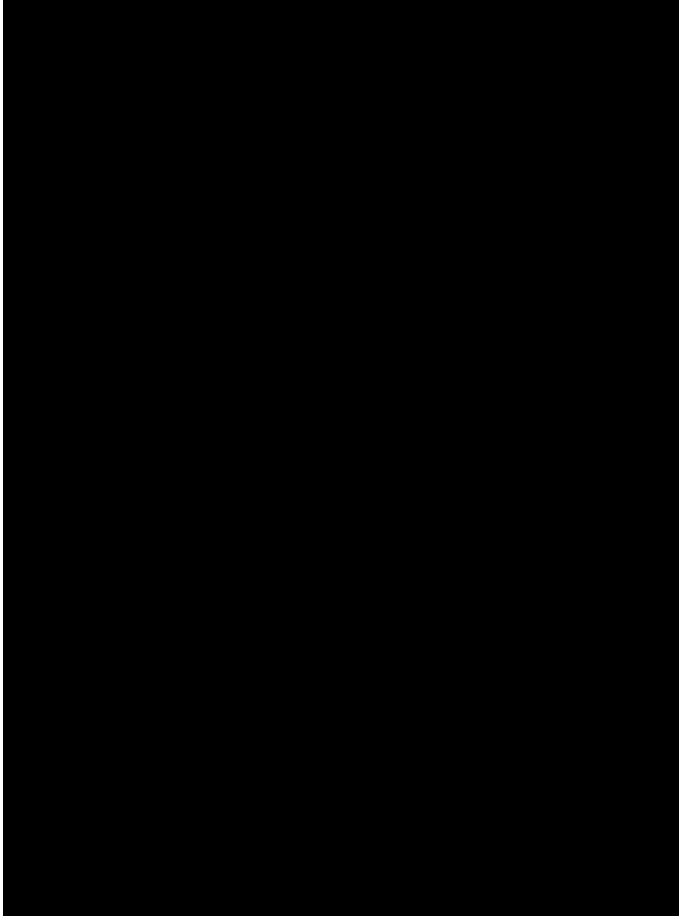

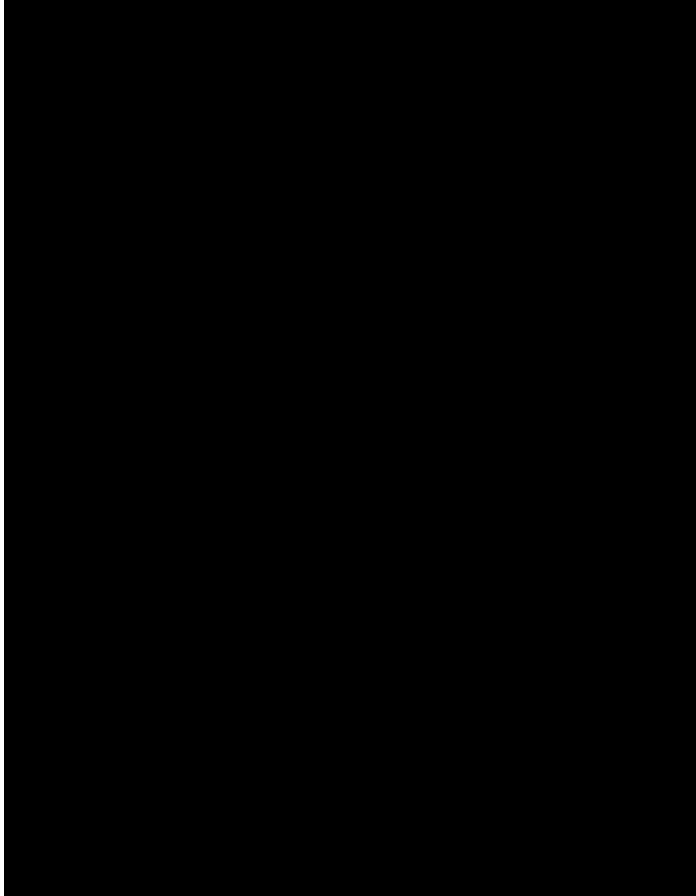
