3 Report from the Interim Executive Director, Department on Aging, requesting
4 authorization to amend 2020 nutrition services purchase of service contracts, by
5 recommending adoption of the following:

7 **A RESOLUTION**

9 WHEREAS, the Department on Aging (Aging) administers Senior Dining
10 Programs to address food insecurity, and the need for nutritious balanced meals for
11 residents over age 60 in Milwaukee County (the County); and
12

13 WHEREAS, Aging works with several vendors and caterers that have
14 expertise in nutrition and culturally appropriate meal planning; and
15

16 WHEREAS, Aging has identified \$100,000 of the funds allocated to the
17 County from the Coronavirus Aid, Relief, and Economic Security Act, available for a
18 one-time funding increase to these programs, in response to the economic fallout of
19 the Coronavirus Disease (COVID-19) pandemic; and
20

21 WHEREAS, authorizing an increase to the 2020 meal site supervision
22 services contracts by \$100,000 enables Aging to partially reimburse vendors for
23 costs incurred in 2020, and to support increased meal demand as a result of the
24 COVID-19 pandemic; and

26 WHEREAS, the Committee on Health and Human Needs, at its meeting of
27 October 28, 2020, considered File No. 20-742 for informational purposes only; and

29 WHEREAS, the Committee on Finance, at its meeting of December 10, 2020,
30 recommended adoption of File No. 20-743 (vote 6-0); now, therefore,

32 BE IT RESOLVED, the Interim Executive Director, Department on Aging, is
33 hereby authorized to execute amendments to 2020 contract awards in the amount of
34 \$100,000, with the following meal site supervision service vendors for the period
35 January 2020, through December 2020, in the amounts enumerated as follows:
