AN AMENDED AND ENGROSSED RESOLUTION

Authorizing and directing the Department of Parks, Recreation, and Culture to collaborate with the Office of Strategy, Budget and Performance and the Office of Corporation Counsel to petition the Wisconsin State Historic Preservation Office to nominate and register the Mitchell Park Domes on the National and State Register of Historic Places

WHEREAS, the Mitchell Park Domes ("the Domes") were designed in 1955 by Milwaukee Architect Donald L. Grieb and construction began in 1959; and

WHEREAS, the Show Dome was the first Dome to be completed in December 1964, the Tropical Dome in February 1966, and the Desert Dome in October 1967, and in 1965 First Lady Mrs. Lydon B. (Lady Bird) Johnson dedicated the Mitchell Park Domes; and

WHEREAS, the Domes are a historical landmark in the City of Milwaukee that attracts over 250,000 visitors annually and preservation of the Domes is one of the highest priorities of the Department of Parks, Recreation, and Culture; and

WHEREAS, since 2014, the Department of Parks, Recreation, and Culture has made efforts to restore, repair, and preserve the Domes by installing protective nettings (File No. 16-200), heating, venting, and air conditioning (HVAC) installation (File No. 21-461), conducted a feasibility study, structural inspections, and more; and

WHEREAS, additionally, the Milwaukee County Board of Supervisors adopted File No. 16-200 establishing the Domes Task Force to recommend and evaluate long-term options for the future sustainability of the Domes; and

WHEREAS, at the March 19, 2019, meeting of the Committee on Parks, Energy, and Environment, an informational report (File No. 19-55) was presented and discussed relating to the usage of historic tax credits at the Domes; and

WHEREAS, according to the report, the Wisconsin State Historic Preservation Office has determined that the Domes are eligible to be listed on the National Register of Historic Places maintained by the National Park Service; and

WHEREAS, listing the Domes on the National Register of Historic Places is the gateway towards eligibility for National Park Service administered federal preservation tax credits, which has previously funded programs such as Save America's Treasures and Preserve America; and

WHEREAS, nomination to the National and State Registry of Historic Places would allow the Domes access to federal grants, federal and state historic tax credits, qualification for federal and state charitable income tax deductions for the donation of historic preservation easements, and eligibility for the official State Registry of Historical Places plaque; and

WHEREAS, additionally nominating the Domes to be placed on the Wisconsin State Historic Preservation Register and the National Register of Historic Places could potentially lead to, preservation assistance, increased tourism, formation of public and private partnerships, and attract new donors; and

WHEREAS, the Committee on Parks and Culture (P&C), at its meeting of September 13, 2022, recommended adoption of File No. 22-980 as amended (vote 3-1); and

WHEREAS, the Milwaukee County Board of Supervisors (County Board), at its meeting of September 22, 2022, adopted File No. 22-980, as amended by the County Board (vote 15-3); and

WHEREAS, the County Executive, Office of the County Executive, vetoed File No. 22-980; and

WHEREAS, the County Board, at its meeting of November 1, 2022, referred File No. 22-980 to the Committee on P&C (vote 15-1); and

WHEREAS, the Committee on P&C, at its special meeting of November 10, 2022, recommended adoption of File No. 22-980 (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) hereby requests the Department of Parks, Recreation, and Culture (DPRC) to collaborate with the Office of Strategy, Budget, and Performance, and the Office of Corporation Counsel to nominate the Mitchell Park Domes for the National and State Registers of Historic Places: and

 80 BE IT FURTHER RESOLVED, the County Board does not at this time authorize application for, nor receipt of, Federal or State of Wisconsin historic tax 81 82 credits relating to the Mitchell Park Domes; and 83 84 BE IT FURTHER RESOLVED, the County Board hereby resolves to as soon 85 as practicable adopt a plan for addressing the future and capital needs of the Mitchell Park Horticultural Conservatory, its home in the Mitchell Park Domes, 86 87 and Mitchell Park prior to any creation and/or recognition of a third-party entity 88 which may eventually oversee operations of the Mitchell Park Domes and all or 89 part of Mitchell Park; and 90 91 BE IT FURTHER RESOLVED, the DPRC shall continue to explore additional 92 actions intended to protect and invest in the long-term prosperity of Mitchell 93 Park. 94 95 96 97 s:\committees\2022\november\november 10 p&c\resolutions\22-980 engrossed resolution mitchell park domes taylor 98 (17) and martinez.docx
