 WHEREAS, the Emergency Medical Services (EMS) Division, Office of Emergency Management (OEM), seeks to create 4.0 Full-Time Equivalent Mobile Integrated Health Care (MIH) Clinician positions, to deliver specialty care designed to engage special patient populations in Milwaukee County; and

WHEREAS, over the past 10 years, MIH has become a pivotal program within EMS systems across the United States, engaging patients who have higher risks and special conditions necessitating upstream engagement; and

WHEREAS, the MIH Clinician positions require a valid State of Wisconsin paramedic license and will be filled by individuals experienced in compassionate care, advanced life support, and additional education in care-plan development and management; and

WHEREAS, the recent allocation of Comprehensive Opioid, Stimulant, and Substance Use Program funding has allowed for services to be provided to those who suffer from opioid use disorder, as well as other conditions with factors leading to opioid misuse; and

WHEREAS, the Department of Human Resources has reviewed this request for a new position or additional staffing to determine the appropriate classification (MIH Clinician) and pay grade (NR26), and has submitted a report included in this file; and

WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this request with respect to need, appropriateness, and funding availability, as required per Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of September 2, 2025, recommended adoption of File No. 25-545 (vote 4-0); now, therefore,
