Milwaukee County Departments/Division Participation Summary for June 2022

KEY FINDINGS

For the reporting period of June 2022, total contract dollars awarded was approximately \$4,599,702.

Of that amount, \$3,338,865 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$883,458 or 26.5% of eligible contract dollars and 19.2% of total contract dollars awarded.

For the reporting period of January through June 2022, total contract dollars awarded was approximately \$315,820,338.

Of that amount, \$36.89 million was eligible for DBE/TBE participation. Contracts held by DBE/TBE companies were approximately \$20.13 million or 54.6% and 6.4% of total contracts awarded.

KEY FINDINGS

For the reporting period of July 2022, total contract dollars awarded was approximately \$12,806,197.

Of that amount, \$983,258 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$849,016 or 86.3% of eligible contract dollars and 6.6% of total contract dollars awarded.

For the reporting period of January through July 2022, total contract dollars awarded was approximately \$328,626,535.

Of that amount, \$37.87 million was eligible for DBE/TBE participation. Contracts held by DBE/TBE companies were approximately \$20.98 million or 55.4% and 6.38% of total contracts awarded.

For the reporting period of August 2022, total contract dollars awarded was approximately \$3,514,985.

Of that amount, \$376,978 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$257,247 or 68.2% of eligible contract dollars and 7.3% of total contract dollars awarded.

For the reporting period of January through August 2022, total contract dollars awarded was approximately \$332,141,520.

Of that amount, \$38.25 million was eligible for DBE/TBE participation. Contracts held by DBE/TBE companies were approximately \$21.24 million or 55.5% and 6.4% of total contracts awarded.
