The extension of David Sabel's temporary assignment to higher classification (TAHC) for the period of October 25, 2015 to January 25, 2016 will increase personnel cost by approximately \$788 for salary (\$732) and FICA cost (\$56) for the entire period. The cost for 2015 will be \$578 and for 2016 will be \$209. We will receive 66% cost reimbursement for these costs.
