Agreement between Milwaukee County and Friends of Hales Corners Park & Pool

In February of 2019 we issued an audit Hales Corners Park has benefited from the support of its Friends Group; however, a formal agreement with the organization is needed to achieve adherence to Chapter 13 of the Milwaukee County Ordinances. We made 10 recommendations in the audit that we believed would help Milwaukee County improve its relationship with Friends of the Hales Corners Park and Pool, Inc.

One of the recommendations was for Parks to enter into a formal agreement with the Friends of Hales Corners Park and Pool, Inc. County Board File No. 19-575 seeks approval of a new agreement between the two parties.

At your request, we conducted a review of the proposed agreement to determine if it addressed the recommendations contained in our audit. Of our 10 recommendations, six related to the proposed agreement. We have included an attachment that contains our review of recommendation versus the proposed agreement.

In our report we also noted a number of areas where internal controls could be strengthened by the Friends Group. While the proposed agreement requires the submission of policies and procedures as well as financial documents, at this point it is unclear to what extent the Friends Group has strengthened its internal controls.

Some of the concerns we noted in the audit relate to the monitoring of the relationship between Parks and their Friends group. Overall, we are pleased to see progress made via the execution of the agreement, but we continue to emphasize the need for monitoring by Parks of their agreements.

We would also suggest that Parks consider adding an ability for a shorter notice for termination versus the one year as noted in the agreement. Should there be issues with contract compliance or other concerns, it would be helpful to have an ability to terminate the agreement in less than the currently noted one year.
