  - A. The action requested will result in execution of contracts for freeway towing services between the Milwaukee County Department of Transportation Director's Office and the following vendors. CLASS I: Sector I Menzel Enterprises, Inc. D/B/A Prairie Land Towing, Sector II N&S Towing, Inc., Sector III All City Towing, LLC, Sector IV N&S Towing, Inc., Sector V Ray's Towing, Inc. CLASS II & III (Combined): Sectors I, II, III, IV, V Ray's Towing Inc.
  - B. In accordance with the rates established by the County Board (File No. 16-259), approval of the proposed contracts with an August 1, 2016 effective date is estimated to result in an additional \$22,000 of revenue beyond the 2016 budgeted level. For 2017 and subsequent years of the contracts, Milwaukee County is estimated to realize approximately \$293,000 in revenue annually.
  - C. In accordance with the rates established by the County Board (File No. 16-259), approval of the proposed contracts with an August 1, 2016 effective date is estimated to result in an additional \$22,000 of revenue beyond the 2016 budgeted level. For 2017 and subsequent years of the contracts, Milwaukee County is estimated to realize approximately \$293,000 in revenue annually.
  - D. The income received from these contracts will continue to be budgeted as an offset to property tax levy for the overall expenses of the Milwaukee County Department of Transportation Director's Office where the freeway towing program is administered.
