Report from the Director, Department of Health and Human Services, requesting authorization to execute non-professional service contracts with caterers that support the Senior Dining Program for a total cost not to exceed \$3,085,100 for the period of January 1, 2023 through December 31, 2023, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Area Agency on Aging is mandated to administer programs within Milwaukee County (the County), through Title III-C, Older Americans Act (the Act), that support nutrition programs; and

WHEREAS, the Act provides funding for Senior Dining programs (the Programs), which includes Meals on Wheels, the Dine-Out Program, and the meals served at the network of congregate and pick-up meal sites throughout the County; and

WHEREAS, the Programs not only help directly alleviate food insecurity, but also promotes the health and well-being of older adults by incorporating wellness checks into meal delivery, and encourages access to supportive services, including evidence-based prevention programs; and

WHEREAS, over half a million meals are served through the Programs annually, which surged to just over 700,000 meals in 2020, during the Coronavirus Disease pandemic; and

WHEREAS, consistent with Section 59.52(31)(c), Wisconsin State Statutes, Aging and Disability Services, Department of Health and Human Services, must, on behalf of the Commission on Aging, bring contracts with a value or aggregate value of \$300,000 or more to the Milwaukee County Board of Supervisors for authorization; and

WHEREAS, the Committee on Finance, at its meeting of December 8, 2022, recommended adoption of File No. 22-1111 (vote 6-0); now, therefore,

38 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
 39 authorizes the Director, Department of Health and Human Services, or her designee,
 40 to execute non-professional service contracts with caterers that support the Senior
