3. Scored group interview of applicants to serve on the Youth Commission in 2025 for the following open districts. Members of the Committee will provide their objective interview scores to the Office of Strategy, Budget, and Performance support staff to determine the top scorer for each district who will be recommended to the Committee of the Whole for confirmation based on the combined score, which consists of up to 15 points for the application, up to 15 points for the interview, up to 3 administrative points based on each applicant's responsiveness through the interview process, and 3 points based on experience/incumbency.

Applicants scored through this process will be recommended to the Committee of the Whole for confirmation to serve from to serve from January 2-August 31, 2025, or September 1, 2025-August 31, 2026, due to the new term dates that will take effect in 2025 with approval from the Milwaukee County Board of Supervisors in the December 2024 cycle. Any members of the Committee who have a conflict of interest because they are or know one of the candidates will recuse themselves from scoring or voting on that district. The one exception is that committee members who are not also applicants must score and vote on the districts in which there are incumbent candidates who currently serve as their colleagues.

Open districts in 20205 include: Districts 2, 4, 5, 7, 9, 10, 11, 12, 13, 14, 15, and 18.
