**REQUEST**

The Superintendent, Milwaukee County Community Reintegration Center (CRC), is requesting authorization to abolish 1.0 FTE Plumber position, pay grade 5417 and create 1.0 FTE Plumber Supervisor position, pay grade 5419.

**BACKGROUND**

The 2023 Milwaukee County Adopted budget includes 2 funded Plumber positions.

The CRC is the City of Franklin's largest water consumer. Leadership at the CRC has determined that there is a need to have greater leadership in the plumbing trades. Therefore, the CRC would like to add a Plumber Supervisor to lead and instruct the plumbing area in the maintenance department. This position exists in other County department with like duties. The requested create of Plumber Supervisor is intended to standardize positions and address equity issues within the County.

Creation of a new Plumber Supervisor position will accurately align the position with the responsibilities and the duties it is assigned and will better address the needs of the Department.

**RECOMMENDATION**

The Superintendent, Milwaukee County Community Reintegration Center, is recommending abolishing 1.0 FTE Plumber position, pay grade 5425 and create 1.0 FTE Plumber Supervisor position, pay grade 5423.
