From the Interim Director, Department of Parks, Recreation, and Culture, requesting authorization to amend Section 47.32 of the Milwaukee County Code of General Ordinances to remove fees related to the Mitchell Park Conservatory, by recommending adoption of the following:

AN AMENDED RESOLUTION/ORDINANCE

WHEREAS, the Department of Parks, Recreation, and Culture provides an updated list of fees in every annual budget; and

WHEREAS, the Milwaukee County Board of Supervisors (County Board) deliberate and approve the fees proposed to raise revenue for each department; and

WHEREAS, the Committee on Parks, Energy, and Environment (PE&E), at its meeting of March 13, 2018, recommended adoption of File No. 18-191 (vote 4-0); and

WHEREAS, the County Board, at its meeting of March 22, 2018, referred File No. 18-191 back to the Committee on PE&E (vote 18-0); and

WHEREAS, the Committee on PE&E, at its meeting of June 12, 2018, recommended adoption of File No. 18-191 as amended (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 47.32 of the Milwaukee County Code of General Ordinances by adopting the following:

AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

SECTION 1. Section 47.32 of the General Ordinances of Milwaukee County is hereby amended as follows:

47.32. - Admission charges and parking fees at the county zoo and ~~Mitchell Park Conservatory~~ and Mitchell Park Conservatory.

~~(a) — The following fees shall be charged for admission to the Mitchell Park Conservatory: From 9:00 to 10:30 a.m., Monday through Friday, excluding major holidays, no charge for a resident of the county; for persons residing outside of the county, the admission fee shall be three dollars (\$3.00) for adults and one dollar and seventy five cents (\$1.75) for children under eighteen (18) years of age, the disabled and senior citizens presenting a county older adult I.D. card or other valid, legal form of identification. Nonresident senior citizens will be charged the regular adult admission~~

46 ~~fee of three dollars (\$3.00). Minimum evening rental fee shall be four hundred dollars~~
47 ~~(\$400.00) plus four dollars and fifty cents (\$4.50) per person.~~

49 (a) Any changes to admission charges at the Mitchell Park Conservatory shall be
50 approved by the county board. Current fees will be published in the adopted county
51 budget each year.

53 ~~(b)~~ (a)(b) Except as provided in subsection ~~(d)~~ ~~(e)~~ (d) hereof, the following fees shall
54 be charged for admission to the county zoo: The admission fee shall be
55 fifteen dollars and fifty cents (\$15.50) for nonresident adults, twelve dollars
56 and fifty cents (\$12.50) for nonresident children twelve (12) years of age
57 or younger, thirteen dollars and seventy-five cents (\$13.75) for county
58 resident adults, ten dollars and seventy-five cents (\$10.75) for county
59 resident children twelve (12) years of age or younger, fourteen dollars and
60 fifty cents (\$14.50) for nonresident senior citizens and twelve dollars and
61 seventy-five cents (\$12.75) for county resident senior citizens presenting
62 an older adult I.D. card, or other valid, legal form of identification, eleven
63 dollars and fifty cents (\$11.50) for nonresident education adult, ten dollars
64 and seventy-five cents (\$10.75) for county resident education adult, eight
65 dollars and fifty cents (\$8.50) for nonresident education junior, seven
66 dollars and seventy-five cents (\$7.75) for county resident education junior,
67 eleven dollars and fifty cents (\$11.50) for nonresident group adult, eleven
68 dollars and fifty cents (\$11.50) for county resident group adult, eight
69 dollars and fifty cents (\$8.50) for nonresident group junior, eight dollars
70 and fifty cents (\$8.50) for county resident group junior. The above fees
71 apply from April 1 through October 31. From November 1 through March
72 31, the following fees shall be charged: thirteen dollars (\$13.00) for
73 nonresident adults, ten dollars (\$10.00) for nonresident juniors, eleven
74 dollars and twenty-five cents (\$11.25) for county resident adults, eight
75 dollars and twenty-five cents (\$8.25) for county resident juniors, eleven
76 dollars and fifty cents (\$11.50) for nonresident senior citizens and nine
77 dollars and seventy-five cents (\$9.75) for county resident senior citizens
78 presenting an older adult I.D. card, or other valid, legal form of
79 identification. The admission fee shall be nine dollars and twenty-five
80 cents (\$9.25) for adults and six dollars and seventy-five cents (\$6.75) for
81 children every Wednesday of each month for county residents, except
82 holidays. Admission fees are waived for county residents on Thanksgiving,
83 Christmas and New Year's. There will be one (1) free day per month for
84 both county and non-county residents, from January through March, and
85 in October, November, and December. In all instances, parking fees will
86 continue to be charged.

87 ~~(c)(b)~~ (c) Except as provided in subsection ~~(d)~~ (c) hereof, the following fees shall be
88 charged for parking at the county zoo parking lot: twelve dollars (\$12.00)
89 per car at all times when the zoo is open to the general public; sixteen
90 dollars (\$16.00) per bus whenever the zoo is open to the general public;
91 five dollars (\$5.00) per car charged for zoological society sponsored
92 private events held at the zoo during the evening.

94 ~~(d)(e)~~ (d) The zoo director is authorized to waive admission and bus parking
95 charges for handicapped groups, county educational groups and members
96 of the Zoological Society of Milwaukee County, including spouses and
97 minor children.

99 **SECTION 2.** The provisions of this ordinance shall be effective upon passage
100 and publication.
