## A RESOLUTION

WHEREAS, there are not enough Crime Analyst positions to cover the responsibilities that were historically covered by 3.0 Full-Time Equivalent (FTE) Deputy Sheriffs and 1.0 FTE Correctional Officer; and

WHEREAS, the Analytics Division, Office of the Sheriff (Sheriff), currently consists of 1.0 FTE Business Intelligence Analyst (working title Crime Analyst) position and 1.0 FTE Data Analyst position to handle an extensive number of responsibilities, requests for data, dashboard creation, and mandated reporting to the State of Wisconsin; and

WHEREAS, these Crime Analyst positions are requested to perform specialized duties at an exceptional degree of competence, which is essential for the analysis of law enforcement data in accordance with best practices, allowing the Sheriff to make more efficient and effective operational decisions; and

WHEREAS, the Sheriff proposes to address the need for the Crime Analyst position in General Investigations, Sheriff, by abolishing 1.0 FTE Deputy Sheriff Captain position (Pay Grade NR31E) in 4002 - Administration and creating 1.0 FTE Business Intelligence Analyst (working title Crime Analyst) position (Pay Grade NR27) in 4052 - General Investigations; and

WHEREAS, the Committee on Personnel, at its meeting of June 10, 2025, recommended adoption of File No. 25-363 (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) hereby authorizes and approves the following position actions for the Office of the Sheriff (Sheriff), as outlined in the report hereto attached to this file and summarized below:
