

 - A. Approval of this resolution will urge the Wisconsin State Legislature to amend Wisconsin State Statute 175.47 to include new language to expand the definition of "jail officer," and to include the term "jail officer" each time the term "law enforcement officer" appears throughout the legislation. The resolution also requests the County's Government Affairs Staff to provide a copy of the resolution to State Legislators and the Governor. If 175.47 is amended as suggested, the Milwaukee County Jail and House of Correction would be subject to the provisions and governance of the statute, which currently does not apply to them.
 - B. Approval of this resolution will not require an expenditure of funds, but will require existing staff time to communicate its contents to the appropriate individuals.
 - C. No budgetary impacts are associated with this proposed action.
 - D. No assumptions were used.
