

- A. Approval of this reallocation will Increase the annual salary expenditure for Elections Commission area under the County Clerk approximately \$7,061 effective in Pay Period 3 of 2020.
 - B. The additional increase in cost for the entirety is estimated to be \$7,061 inclusive of 7.65% for FICA.
 - C. This move will be absorbed into the agency's budget and partially offset by abolishments included in an overall MCEC reorganization.
 - D. FICA costs of an additional 7.65% have been added to the salary increase amounts.
