
DESCRIPTION OF FISCAL EFFECT

- A. If approved, this resolution/ordinance codifies Milwaukee County's policy to provide reasonable break times and comfortable accommodations for breastfeeding employees. The resolution also authorizes Facilities Management to evaluate and report back to the County Board regarding placement of nursing/pumping sites throughout County property for public use.
- B. It is anticipated that most departments have the ability to accommodate breastfeeding employees within their existing space and that any ancillary costs can be absorbed within each department's budget. Public nursing/pumping sites, such as the freestanding lactation suites at the airport and zoo, can range in cost from \$11,000 - \$15,000 dollars, but there are also opportunities to defray costs by partnering with media sponsors.
- C. Small increases in operating expenditures to accommodate breastfeeding employees may occur in this and subsequent years, but these costs should be absorbed within each department's budget.
- D. No assumptions or interpretations were utilized to provide information for this form.
