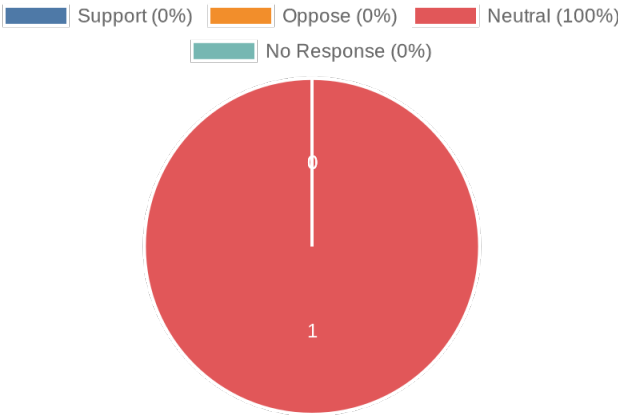

**Overall Sentiment**



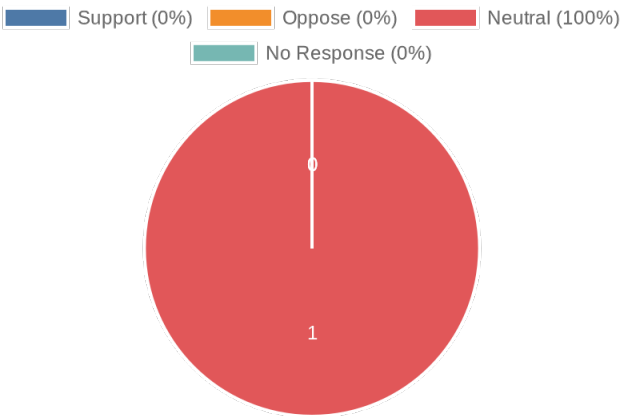

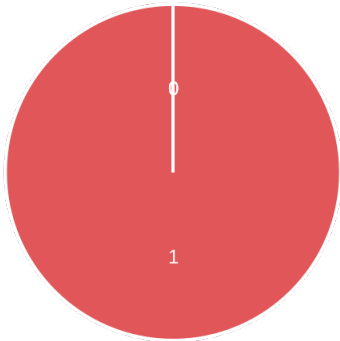
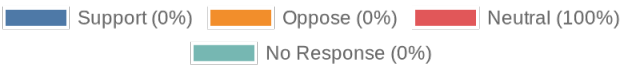
