12 **A RESOLUTION**

14 WHEREAS, on August 29, 2013, Milwaukee County (the County) received a
15 \$200,000 funding award notice from the United States (U.S.) Bureau of Justice
16 Assistance (BJA) supporting the County's Adult Drug Treatment Court (DTC) program
17 with a grant period of October 1, 2013, through September 30, 2015; and

18
19 WHEREAS, on December 19, 2013, the Milwaukee County Board of Supervisors
20 (County Board) authorized the Chief Judge to execute a Professional Services Contract
21 with JusticePoint, Inc., and the University of Wisconsin-Milwaukee for provision and
22 evaluation of the County's Adult DTC program under Adopted File No. 13-887; and

24 WHEREAS, the County Board adopted the 2015 Budget on November 10, 2014,
25 under File No. 14-765, and the Budget was approved by the County Executive; and

26
27 WHEREAS, as of July 1, 2015, there is a remaining balance of \$57,611.18 in
28 BJA-DTC funding; and

30 WHEREAS, on September 1, 2015, the County received notice from the U.S.
31 BJA agreeing to an extension of the grant period through December 31, 2015, to allow
32 the expenditure of remaining grant funds; and

34 WHEREAS, the Committee on Judiciary, Safety, and General Services, at its
35 meeting of October 22, 2015, recommended adoption of the Chief Judge's request
36 (vote 5-0); and

38 WHEREAS, the Committee on Finance, Personnel, and Audit, at its meeting of
39 November 2, 2015, recommended adoption of the Chief Judge's request (vote 8-0);
40 now, therefore,

42 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
43 authorizes the Chief Judge to extend the grant period for the United States Bureau of
44 Justice Assistance Adult Drug Court Discretionary Grant Program from the original end
45 date of September 30, 2015, to December 31, 2015, to allow the expenditure of the
46 remaining grant funds totaling \$57,611.18.
