A. The Executive Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute purchase of service contracts and contract amendments with community vendors.

Approval of this request will allow DHHS to continue provision of contracted housing supportive services, reentry services to residents at the Community Reintegration Center (CRC) as well as case management for survivors of domestic violence.

B. The My Way Out and Medical College of Wisconsin contracts under the Smart Reentry Program are funded by a Bureau of Justice Assistance federal grant. Supportive housing and case management contracts with the Benedict Center and Community Advocates are funded by an ongoing Continuum of Care Domestic Violence grant from the U.S. Department of Housing and Urban Development (HUD). Total related expenditures and revenues—contracts (\$291,132) and amendments (\$162,414)—equal \$453,546.

C. There is no tax levy impact associated with approval of this request as federal grant revenues are sufficient to cover associated expenditures.

D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
