 - A. Amend a contract with the Indian Council for the Elderly to provide catering and meal site supervision at its All Nations senior center in 2026 from \$85,000 to \$105,000 to align with the amount previously approved by the Commission on Aging and incorporated into the 2026 Milwaukee County Area Agency on Aging planning budget.
 - B. This amendment would increase the amount of the contract between the Area Agency on Aging and the Indian Council of the Elderly by \$20,000. This amount would be distributed from budgeted revenues as follows:
Base County Assessment: \$12,344
Older Americans Act Title IIIC1: \$72,572
Older Americans Act Title IIIB: \$20,084
 - C. These revenues were previously included in the 2026 Area Agency on Aging planning budget within allocated revenues.
 - D. No assumptions or interpretations were made.
