PROVISIONS:

- 1. <u>COMPENSATION; BILLING.</u> Section 5(a), <u>Compensation</u>, the last sentence of this paragraph is amended by deleting "Unless subsequently approved the County, the maximum amount for fees to be paid under this Contract is \$99,999" in the last sentence of the first paragraph, and replacing it with "Unless subsequently approved by the County, the maximum amount for fees to be paid under this Contract is \$248,000".
- 2. <u>CONFLICT</u>. In the event of any conflict between the terms and provisions of this Amendment and the terms and provisions of the Contract, the terms and provisions of this Amendment shall govern, control and prevail.
