#### **BACKGROUND**

In July of 2023 CAMPAC recommended that the proposed funding formula transition outlined in File 21-90 be reinstated.

With the recommended formula determined, applications for the 2025 Fund for the Arts were open on the mymilwaukeecounty.com portal from July 7, 2025, through August 1, 2025. Forty-eight total applications were received.

Through reinstating File #21-90 the funding formula applies equal distribution of the total Fund for the Arts budget (\$307,825) dividing by the number of applicants (48) for an allocation of \$6,413 per organization. Following past practice, this includes an allocation for sponsorship of summer concerts operating within Milwaukee County Parks. These recommendations were confirmed by the CAMPAC at its meeting on August 5, 2025.
