Approval of this resolution requests Milwaukee County's Information Management Services Division (IMSD), in collaboration with the Office of Corporation Counsel, the Office of the Sheriff, and other relevant stakeholders, including privacy and free speech advocates, to develop a comprehensive policy framework to regulate both existing surveillance technology and the implementation of any new surveillance technology, and to provide a recommendation to the Milwaukee County Board of Supervisors no later than May 2026, with a progress report provided no later than the December 2025 meeting cycle. The resolution expresses support for a pause on acquiring new facial recognition technology until policies for regulating existing and new surveillance technology can be developed and approved. Existing staff time will be required to develop the policy framework.
