

- A. Requesting authorization to apply for a Greater Milwaukee Foundation Parks Fund grant to support enhancements and new improvements to Tiefenthaler Park. In tandem with a separate item that would enable a long-term lease of the park pavilion to the PEAK Initiative, these requests represent a comprehensive plan to revitalize this park. Funds would support athletic field improvements, lighting enhancements, play structures, and other improvements to increase use of the park.
