# **REQUEST:**

This informational report is being submitted as directed by File No. 21-42 which requests regular informational updates on the status of the Mental Health Emergency Center (MHEC).

# **BACKGROUND**

In December 2020, the Milwaukee County Department of Health and Human Services signed a letter of intent with four area health systems to create a new psychiatric emergency room that will quickly assess and treat individuals in psychiatric distress. This new facility will reduce criminal justice system involvement for mentally ill, provide meaningful connections to community mental health services, and reduce potentially unnecessary psychiatric hospitalizations.

The facility will serve all residents regardless of ability to pay. Revenues are not anticipated to fully cover costs of providing care. The private healthcare partners have agreed to subsidize 50 percent of the operational deficit with the remaining subsidy coming from Milwaukee County. This project represents an innovative public-private partnership aimed at providing high quality emergency mental health services in a location that is convenient and accessible.

### **UPDATE**

As of July 2021, this project has made substantial progress in terms of both agreements and progress on facility construction. Both the Member Agreement, the agreement

defining the relationship between Milwaukee County and the four area health systems to oversee and financially subsidize this program, and the Master Service Agreement, the agreement defining the relationship between the MHEC governance body and the service operator (Advocate Aurora Health), have been fully signed and executed. These agreements represented the final step in formalizing the MHEC governance and commitment from all parties.

As of July 7, 2021, the City of Milwaukee Common Council approved all necessary permitting to move forward on construction at the site located on 12<sup>th</sup> and Vliet. Fencing has been installed onsite. Asphalt removal is expected to begin July 19.

Simultaneous to construction, Advocate Aurora is beginning operational implementation for the MHEC. The Administrator position, the role that will oversee operations at the MHEC, as been posted while other operational buildout continues.

# ALIGNMENT TO STRATEGIC PLAN

This project is critical in providing continued access and treatment for individuals in psychiatric distress which is aligned with the strategic plan in determining how services get delivered to advance health equity.
