

AGREEMENT BETWEEN
THE WISCONSIN DEPARTMENT OF TRANSPORTATION
AND
THE MILWAUKEE COUNTY OFFICE OF THE SHERIFF

2020 Traffic Mitigation
I-94 NS North Segment

This agreement made and entered into between the Wisconsin Department of Transportation (DEPARTMENT) and the Milwaukee County Office of the Sheriff (COUNTY), to provide for services as described herein. The Wisconsin Department of Transportation and Milwaukee County Office of the Sheriff are coordinating during the I-94 NS Project North Segment (PROJECT) to mitigate traffic impacts and to ensure that emergency response capabilities are not adversely affected by roadway reconstruction.

The DEPARTMENT advises implementation of a comprehensive and cost effective transportation management plan that will help ensure the safety, accessibility and mobility for the traveling public in the PROJECT area. The PROJECT area is defined as interstates I-94 from Milwaukee Co Line on the south and College Avenue on the north. Included in the PROJECT area are local alternate route streets within two miles of the interstate roadways.

To mitigate traffic impacts caused by the PROJECT, the DEPARTMENT will provide \$307,303.08 to the COUNTY as specified in Attachment A: Milwaukee County Office of the Sheriff - Cost Estimate. In turn, the COUNTY will provide planning, coordination and staffing services (as outlined below) in an effort to mitigate emergency incidents in the PROJECT area and stay informed of PROJECT roadway closures and construction progress for approximately a half year period commencing on January 1, 2020 and ending on July 1, 2020.

The COUNTY shall provide a sheriff deputy patrol, properly trained in work zone safety and mobility, dedicated to the defined PROJECT area for first, second, and third shift: twenty-four hours per day, seven days a week between January 1, 2020 and July 1, 2020. The DEPARTMENT reserves the right to reduce patrol hours if deemed not necessary by the construction project staging.

The monies provided by this agreement will allow for dedicated staff to assist in:

- Respond to freeway crashes and incidents
- Assist with planned/unplanned freeway, lane, ramp, and shoulder closures, including overnight freeway closures
- Clear minor debris that is disruptive to traffic flow
- Roadway monitoring, clearance of incidents and speed enforcement
- Ensure consistent staffing of mitigation officer
- Participate in incident “dry run” exercises
- Assist in development of an Incident Crisis Communications Plan

- Provide crash reports and incident data when requested
- Being on-call to the DEPARTMENT's Project Manager and the DEPARTMENT's contractors to perform these duties:
 - Overnight closure assistance
 - Patrol PROJECT area with one deputy for first, second, and third shifts during construction.
- Strategy includes costs for cell phones to communicate with contractors/DEPARTMENT construction staff

The COUNTY shall provide patrol staff billed at the Deputy Sheriff straight time with an overhead included hourly rate of \$52.02 per hour in 2020. The project wage and benefit rate includes retirement, FICA and communication costs.

The COUNTY shall also provide closure assistance for freeways, lanes, shoulders, and ramps. The COUNTY shall provide closure assistance using staff to be billed at the Deputy Sheriff overtime hourly rate of \$56.89 per hour in 2020.

The COUNTY shall equip each mitigation squad per shift with a mobile telephone with email capabilities. The mobile telephone is to be maintained by the COUNTY.

Enhanced Project Patrol Squad

The COUNTY shall also provide and properly equip an enhanced construction project patrol vehicles. Mileage to be billed out at actual cost.

Basis of Payment

The COUNTY shall charge actual costs incurred and attributable to the work performed and described above under this agreement to the DEPARTMENT. The DEPARTMENT will provide to the COUNTY reimbursable funding for these functions in the amount of \$307,303.08 Total reimbursement to the COUNTY for traffic mitigation measures under this agreement will not exceed \$307,303.08 Billings shall be directed by the COUNTY to the attention of Keegan Dole, Wisconsin Department of Transportation, Southeast Region, 141 NW Barstow Street, P.O. Box 798, Waukesha, WI 53187-0798 and will include a statement of expenses supported by a description of items and services provided and expended. The DEPARTMENT shall pay the billings promptly upon receipt thereof.
