- A. Implementation of 2013 Wisconsin Act 14 with regard to purchase of professional service agreements (under the Milwaukee General Ordinance Chapter 56) for Capital projects requires County Board approval to award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$300,000.
- B. A fee increase to an existing professional service agreement with The Sigma Group to provide professional design services for 2015-16 Adopted Capital Project WP298 – South Shore Park Improvements is being requested that would add \$153,260.00 to the current agreement resulting in a total agreement value of \$382,832.00.
- C. There are sufficient funds in the current WP298 capital budget to award the requested fee increase for The Sigma Group, which will allow the south parking lot, dockwall, promenade design, storm water controls, site lighting and attendant booth to be designed concurrently as the north parking lot and amenities.
- D. A grant for \$800,000 is approved from Waterways for recreational boating that will provide the needed funding for construction of certain features on the south side of the parking lot.
