A. Authorization for Milwaukee County Parks to enter into a Lease Agreement with COA Youth and Family Centers for use of certain space in the Moody Park community building and adjacent areas. The term of the lease is five years with two one-year renewals. In lieu of rent payments, COA will provide routine building maintenance and will contribute \$110 per month to utility costs.

B. If this resolution is approved, Parks will receive utility payments of \$110 per month or \$1,320 annually. Additionally, Parks will not be responsible for providing routine building maintenance.

C. Parks will receive \$110 per month in utility reimbursement for the term of the lease.

D. No assumptions were utilized.
