MINUTES

I. CALL TO ORDER AND ROLL CALL

Advisory Council Chair, Ellen Pimentel, called the meeting to order at 1:03 p.m., and Emily Petersen, AAA took the roll call. A quorum of Council members was not present. A quorum was obtained later in the meeting.

II. REVIEW AND APPROVAL OF OCTOBER 16, 2025, ADVISORY COUNCIL MEETING MINUTES

III. REPORT FROM ADVISORY COUNCIL EX OFFICIO MEMBER

communities, vendor contracts and other work by the Commission on Aging. The Council discussed with no action taken.

IV. DISCUSSION OF OLDER AMERICANS ACT AND 2025-2027 AREA PLAN GOALS

The Council discussed the Older Americans Act (OAA) and the 2025–2027 Area Plan goals related to social supports and socialization programs. Staff reviewed OAA requirements, focusing on the definitions of “greatest economic need” and “greatest social need,” which guide service priorities in Milwaukee County.

V. PRESENATION BY JILL KNIGHT, PROGRAM COORDINATOR OF MILWAUKEE COUNTY AREA AGENCY ON AGING SOCIAL SUPPORT AND SOCIALIZATION PROGRAMS

Jill Knight, Program Coordinator, Area Agency on Aging, provided an overview of the Milwaukee County Area Agency on Aging’s supportive services, including senior centers and socialization programs. She emphasized that most services have no income or asset limits and are available to Milwaukee County residents aged 60 and older. Members discussed outreach challenges, unmet needs, and strategies for connecting isolated older adults, including partnerships with healthcare providers, faith-based organizations, and community groups. The Council discussed the item with no action taken.

VI. 2025 AREA AGING PLAN YEAR-IN-REVIEW

The Council discussed receiving a 2025 annual report on the Area Aging Plan at the January 2026 meeting. Due to time constraints, the Council did not discuss the attachment to the item and tabled it until the January 2026 meeting.
