- B. This fee increase adds \$52,326.29 to The Sigma Group's professional service agreement for a total not to exceed fee of \$291,121.90 to provide professional design and construction oversight services for capital project WO0535 – War Memorial Center – North Lot Design and Greenprint Plan.
- C. There are sufficient funds in capital budget WO0535 to award the requested fee increase for additional design and construction oversight services under the professional services agreements to The Sigma Group.
