The DCS can provide free information, assistance and support to adults with memory concerns and or dementia and their family members or caregivers. Some of the DCS services include dementia specific programing, outreach, family consultations, care planning, community events, memory screening and more.

MCTS WisGo Reduced Fare Card Phone: 414-937-3218.

For persons 65 years of age and older, children ages 6-12, persons enrolled in Medicare, Transit Plus clients, or persons with qualifying disabilities receive \$1 rides on MCTS buses, paying no more than \$2 per day, \$11/week and \$32/month. The Reduced Fare can be used with the card, UMO app or cash. With a multitude of routes, the MCTS buses can take you throughout the county.

The Milwaukee Mobile Crisis team supports callers on the Milwaukee County Crisis Line and provides mental health crisis responses and intervention to individuals of all ages, in the community. This non-police mobile response provides services 24 hours a day, seven days a week and is composed of counselors, therapists, psychologists and nurses.

Children's Community Options Program

Provides a coordinated approach to supporting families who have a child with disability. CCOP maximizes the family's capacity, resiliency, and unique abilities to better support, nurture, and promote self-determination, independence and inclusion in the community. CCOP is funded with the Wisconsin's General Purpose Revenue and can be used in conjunction with CLTS Waiver as the funding of last resort.

Birth to 3

The Wisconsin Birth to 3 Program is committed to serving children under the age of 3 with developmental delays and disabilities and their families. Birth to 3 program takes the value of the family's primary relationship with their child and work in partnership with the family. Birth to 3 program is developed to enhance the child's development and support the family's knowledge, skills and abilities as they interact with and raise their child.

Below-market rate loans to eligible property owners in participating municipalities in Milwaukee County. Due to restrictions on these funds, the program does not service the City of Milwaukee, City of West Allis, or the Village of River Hills, but does serve the remaining communities of Milwaukee County. Common items repaired through Milwaukee County Home Repair include hot water heaters, furnaces, sewer laterals, roofs, siding, trim, windows, porches, foundations, plumbing and electrical. Grant funds are available for persons with disabilities needing home modifications for accessibility, such as ramps, lifts, and bathroom modifications.

Housing Choice Voucher Program (Section 8) Phone: 414-278-4894

Milwaukee County is not accepting Section 8 applications at this time. Section 8 is funded by the US Department of Housing and Urban Development (HUD). This program is designed to help low-income families and individuals with rent assistance for decent, safe, and sanitary housing, provided by private owners and rental agents.

The Energy Assistance Program provides qualified Milwaukee County residents with a one-time, annual payment toward heating and electric bills. The funding pays a portion of energy costs determined by household size, income, and energy costs. The benefit is usually paid directly to the energy supplier. Individuals who qualify for Energy Assistance, may also be eligible for Emergency Crisis Assistance, crisis Prevention Assistance, Heating System Repair/Replacement, Fuel or Weatherization Program.
