A. Milwaukee County Parks is requesting authorization to enter into a Project Partnership Agreement (PPA) with the Department of the Army and the Milwaukee Metropolitan Sewerage District (MMSD) and an Intergovernmental Cooperation Agreement (ICA) and Permanent Easement with MMSD for a habitat restoration project of the Honey Creek. The PPA holds the non-Federal sponsors jointly and severally liable for 35 percent of the project costs, approximately \$4.5 million, and MMSD is contractually obligated under the ICA to provide all costs associated with the PPA.
