From the Chief Deputy, Office of the Sheriff, requests the authority to execute an agreement with Milwaukee Regional Medical Center Inc. (MRMC) to provide two Deputy Sheriffs to perform law-enforcement related services at the premises of Milwaukee Regional Medical Center Inc. in an amount of \$1,057,892.39, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Milwaukee County Sheriff’s Office (MCSO) is requesting authorization to execute an Agreement with the Milwaukee Regional Medical Center (MRMC) for the purpose of providing law enforcement-related services, including but not limited to: uniformed security services, marked squad operations, critical incident response, and investigations for the period beginning March 31, 2020, and ending midnight on March 31, 2021; and

WHEREAS, MCSO shall station two Deputy Sheriff’s per shift to perform law enforcement-related services during all three shifts, 24-hours per day, 365 days of the year, on or about the premises of the MRMC; and

WHEREAS, MCSO will coordinate with MRMC regarding its activities at MRMC including, but not limited to: service of process, execution of warrants, response to disturbances, investigations, interviews, emergency detentions, patients in custody, traffic control, or missing persons; and

WHEREAS, the Deputy Sheriff’s will coordinate with MRMC security regarding any law enforcement activities by any other law enforcement jurisdiction personnel presenting to the Deputy Sheriff’s at MRMC; and

WHEREAS, all Deputy Sheriff’s will be in full duty uniform, equipped with a duty weapon, protective vest, oleoresin capsicum spray, and a Taser; and

WHEREAS, the Deputy Sheriff’s will operate on MCSO communications frequencies; and

WHEREAS, the rates per hour have been approved by the MCSO Fiscal Administration, and agreed upon by MRMC, but are subject to change per Milwaukee County’s contracts with the Milwaukee Deputy Sheriff’s Association, and the budgets for each fiscal year; and
