A. Authorization to execute Master Lease Agreements with De Lage Landen Public Finance, LLC, Premier Golf & Utility Vehicles, Inc., BankVista, and Versatile Vehicles, Inc., to allow for the lease of golf and utility carts at the Milwaukee County Zoo and various Milwaukee County Parks locations.

B. Milwaukee County expense for the carts is \$531,392.56 per year for four-and-a-half years and with a final buyout payment of \$1,620,500 in 2028.

C. Subsequent year (2025, 2026, 2027 and 2028) budget impacts will be identical to 2024 and will be incorporated into the annual budget requests for those years.

D. Assumptions include that funding will be requested in annual departmental budgets.
