A. The Zoo Director requests authorization for the Department of Administrative Services to transfer \$2,550,000 from the Appropriations for Contingencies to the appropriate capital improvement accounts to complete the Cost to Cure West Entrance Project.

B. A total of \$12.7 million was received from the State Department of Transportation to implement the Remediation Plan to cure the effects of the WisDOT Zoo Interchange Freeway Project on the Milwaukee County Zoo. A total of \$9,825,000 has been approved by the County Board for the Remediation Plan including \$250,000 for other Zoo Interchange projects. The Zoo is requesting the final \$2,550,000 be transferred out the Appropriations for Contingencies to complete the West Entrance. Without these funds, the Zoo will not be able to open the West parking lot and will lose revenues because it will not be able to provide enough parking for Zoo guests.

C. There is a zero tax levy impact to Milwauke County for the Cost to Cure projects because the entire project is funded by settlement funds from the Wisconsin Department of Transportation. D. NA
